Introducing Zero Code

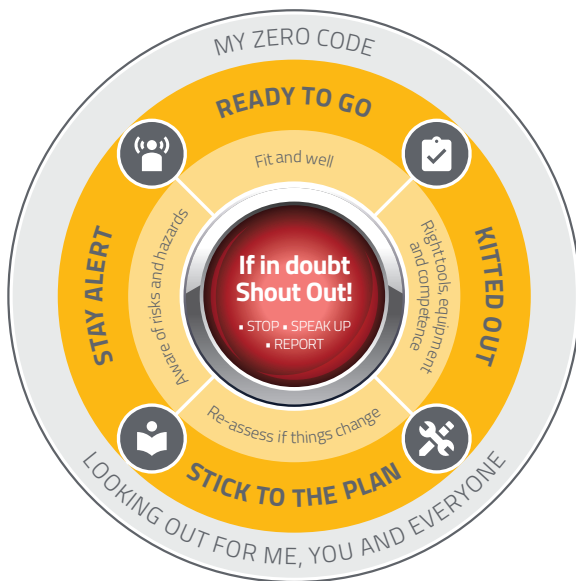
Zero Code, Looking out for me, you and everyone is a simple framework that highlights the key actions we must all take to protect ourselves and others from harm.

By making a personal commitment to Zero Code and focusing on the correct and safe behaviours in the workplace we can be more aware of and remove potential issues that can harm, kill or seriously injure someone.

Zero Code has four simple principles that we all need to adopt to help us think about safety at every stage of a task:

- Ready to go
- Kitted out
- Stick to the plan
- Stay alert.

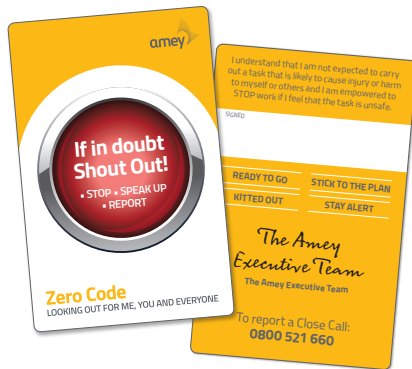


Shout Out!

Zero Code has been designed to empower you to Shout Out! if you see conditions which are not acceptable or safe.

Shout Out cards were issued to all operational employees with the June/July 2022 edition of HUB magazine which was sent to home addresses. There is space for individuals to sign their name to confirm their personal commitment and this is also signed by the Amey Executive Team.

Lead a discussion

Ask your team to share examples of when they think a Shout Out! card could be used.

- Ask everyone to sign their card and encourage them to carry it at all times
- Carry your own card and use it constructively.



Lead a discussion

Watch the Zero Code film (to view, go to amey.co.uk/zerocode) with your team.

Questions to generate a discussion:

- What did you think of the film?
- Do you understand the purpose of Zero Code?
- How is Zero Code relevant to us as a team and you as an individual?
- Does anything concern you about Zero Code?
- Ask why might people be afraid to speak up about safety concerns (worried will get into trouble, labelled a 'grass', don't want to 'interfere')
- Explain how they will always be supported.



Lead a discussion

Read through the below and ask your team to share examples in their day-to-day work that the code applies to.



READY TO GO

- I will attend work, drive vehicles and operate equipment knowing that I am fit and well
- I will always make sure risks have been assessed and that I understand them
- I am clear on what my role is and the value I add to my team.

KITTED OUT

- I will only use the tools and equipment provided and approved for the task
- I will only carry out tasks that I am trained and competent to do
- I will always wear the appropriate personal protective equipment for the job.

STICK TO THE PLAN

- I will make sure I know and understand the plan
- I will always check that I am following processes and safe systems of work
- If things change I will re-assess and only start work again when it is safe to do so.

STAY ALERT

- I will always make sure I am in the safest working position
- I will remain alert to what is happening around me and react accordingly to stay safe
- I will 'Shout Out!' if anything is unacceptable, to keep myself and others around me safe.
